

CHART OF ACCOUNTS

The Chart of Accounts is an accounting system's central library that allows for financial transaction classification. This chart of accounts represents the overall financial classification system for current and future public defender offices.

Each line item will be assigned an individual seven digit account number. These account numbers will be unique for each Corporation. Corporations should not create, modify or otherwise alter the Chart of Accounts. If the Corporation has a specific need, the Corporation should express those needs to Public Defender Services. Public Defender Services will assess the need and determine the proper course of action.

Subaccount Classification

General account group for similar line-items

Detailed Master

A sequential two-digit number for categorizing line-items

Judicial Circuit

Sequential two-digit number that corresponds to the Judicial Circuits
(e.g., 01 First Circuit; 02 Second Circuit; 30 Thirtieth Circuit)

Location/Office/Division

Single digit that details the Corporations' separate organisations
(e.g., 0 is the Main location; 1 - 8 are other organizations; 9 – available to all locations)
